Commander Kerry Boardman 2018-2019 Commander's Project National Emergency Fund (NEF)

The Preamble to The American Legion Constitution sums up the theme of the National Endowment Fund, "... devotion to mutual helpfulness." This phrase is more than just mere words on paper; it's our pledge of support to Legionnaires and their family members. Since the early 1920s, The American Legion has been actively involved in meeting the needs of both the community and individual Legion Family members in the wake of disasters such as hurricanes, tornadoes, earthquakes and wildfires.

The program began in 1969 as a one-time effort in the wake of Hurricane Camille, which devastated the Gulf Coast – primarily Mississippi, and parts of Louisiana and Alabama. The American Legion's National Executive Committee (NEC) approved a resolution in August that year establishing the fund to "meet the most urgent needs through American Legion

NEF was resurrected in 1989 when Hurricane Hugo pummeled the Carolinas and Puerto Rico. The NEC again pledged \$25,000, called for a fundraising drive and approved a resolution stating that any leftover funds would be saved for future natural disasters. Since then, NEF has provided millions of dollars in direct financial assistance to Legionnaires, posts and Sons members. By providing this emergency funding, NEF has prevented damaged posts from $\,$ closing and supported members and their families as they recovered from tragedy.

In 1925, World War I veterans, widows and children continued to struggle to return to a regular life. The members of The American Legion, aware of the grave responsibilities entrusted to them by those who had served, knew the time had come to take action.

Brett P. Reistad 2018-2019 National **Commander of** The American Legion

Brett P. Reistad was elected national commander of The American Legion on Aug. 30, 2018, in Minneapolis during the organization's 100th national convention. He has been a member of the nation's largest veterans' organization since 1981.

A resident of Manassas, Va., Reistad is a life member and past commander of Post 270 in McLean. The Department of Virginia reached an all-time high in membership while he served as department commander from 2005-2006. He retired as a lieutenant with the Fairfax County Police Department after 26 years of service and began a second career as a law enforcement services coordinator for the Regional Organized Crime Information Center of the Regional Information Sharing Systems Program, a congressionally funded law enforcement investigative assistance program of the U.S. Department of Justice. He holds a B.S. degree in Criminal Justice from Virginia's Bluefield College.

Reistad's American Legion membership eligibility is through his honorable Vietnam Warera service (1974-1978) as an active duty U.S. Army infantryman where he served with the Presidential Salute Battery of the 3rd U.S. Infantry Regiment (The Old Guard) at historic Fort Myer, Va. He participated in the inaugural ceremony for President Carter and other highprofile ceremonies. He has since been honored as a Distinguished Member of the Regiment. Reistad has served at every level of The American Legion. He is a past president and honorary life member of the National American Legion Press Association. He recently completed a six-year appointment as chairman of the Department Legislative Committee and two three-year terms as a gubernatorial appointee to the Commonwealth of Virginia's Joint Leadership Council of Veterans Service Organizations where he helped coordinate the input of 23 veterans service organizations in crafting veteran-friendly legislation and advocating the proposed legislation before the governor and General Assembly. He is also a tenured past department historian and was recently bestowed an honorary life membership by the National Association of Department Historians of the American Legion.

He is a past Legionnaire of the Year from Post 270 and a member of the Sons of The American Legion Squadron 10 in Manassas. His wife, Jessica, and his family are proud members of the American Legion Family.

His theme as national commander is "Celebrating Our Legacy," with special emphasis on the organization's centennial.



Executive Order on Strengthening Retirement Security in America Signed August 31, 2018

SECTION 1. POLICY. It shall be the policy of the Federal Government to expand access to workplace retirement plans for American workers. According to the Bureau of Labor Statistics, 23 percent of all private-sector, full-time workers lack access to a workplace retirement plan. That percentage increases to 34 percent when part-time workers are taken into account. Small businesses are less likely to offer retirement benefits. In 2017, approximately 89 percent of workers at private-sector establishments with 500 or more workers were offered a retirement plan compared to only 53 percent for workers at private-sector establishments with fewer than 100 workers. Enhancing workplace retirement plan coverage is critical to ensuring that American workers will be financially prepared to retire.

Expanding access to multiple employer plans (MEPs), under which employees of different private-sector employers may participate in a single retirement plan, is an efficient way to reduce administrative costs of retirement plan establishment and maintenance and would encourage more plan formation and broader availability of workplace retirement plans, especially among small employers.

The Secretary of Labor shall examine policies that would:

- (1) clarify and expand the circumstances under which United States employers, especially small and mid-sized businesses, may sponsor or adopt a MEP as a workplace retirement option for their employees, subject to appropriate safeguards; and
- (2) increase retirement security for part-time workers, sole proprietors, working owners, and other entrepreneurial workers with non-traditional employer-employee relationships by expanding their access to workplace retirement plans, including MEPs.

MEPs

For the small employer market, multiple employer plans would enable small businesses to participate in a single, professionally administered plan that affords them economies of scale and minimal fiduciary responsibility. The plans would provide employees of those organizations the same opportunities to invest for retirement that employees of large companies already enjoy on a near universal basis via 401(k)s and similar defined contribution plans.

The bad news is that while workplace retirement plans are helping tens of millions of working Americans save and invest for retirement, tens of millions more do not have access to a plan at work. This is particularly problematic for workers who are employed by one of the country's many small employers who do not sponsor a plan due to concerns about costs, administrative complexities and fiduciary liability. The resulting retirement coverage gap is reflected in data compiled by the Bureau of Labor Statistics: • 89% of workers employed by firms with more than 500 employees, and 78% at firms with 100 to 499 employees, have access to retirement plans on the job.8 • Only 50% of those employed by firms with fewer than 100 workers have access to a workplace retirement plan.9 The coverage gap's concentration among small employers is critical because small employers provide jobs for a vast swath of the American populace, particularly among women and multi-ethnic groups. In 2011, private sector organizations with no more than 500 workers employed a total of 65.4 million people, while larger organizations employed 51.5 million. The smaller employers also provided more jobs for women—30.3 million versus 25 million—and for Asian American, American Indian and Hispanic workers.10 The retirement coverage gap has persisted despite a variety of legislative and administrative initiatives that have sought to close it via simplified retirement savings vehicles such as Simplified Employee Pension plans (SEPs), Savings Incentive Match Plans for Employees (SIMPLEs), and voluntary payroll-deduction IRAs.

CONCLUSION Access to a cost-effective, easy-to-use workplace retirement savings program is an important tool for building retirement security. Yet, tens of millions of Americans lack access to such a tool. Most in that group are employed by enterprises with 100 or fewer people on their payroll. Revamping the rules and regulations around multiple employer plans to allow for MEPs that meet the needs and concerns of small employers will help to close the retirement coverage gap and improve the retirement outlook for millions of working Americans. It will give those workers access to professionally managed, institutionally priced retirement programs funded via convenient payroll deduction. And it will help make small employers more competitive with larger employers who can more easily assume the costs and responsibilities associated with sponsoring a retirement plan. Importantly, incorporating retirement income solutions into MEPs will be crucial to delivering maximum benefits to working Americans. As has become increasingly clear over the past decade as the first wave of Baby Boomers has begun to exit the workforce, retirement savings plans must function not merely as vehicles for accumulating assets but also as vehicles for converting those assets to income once plan participants have stopped working.

This executive order will take effect after the conditions and rules of current law have been changed and the new restrictions for MEPs have been satisfied. This timeline seems to be set for one year.

National Commander's Pin Incentive Program

American Legion National Commander Brett P. Reistad will award his national commander "Membership Excellence: Team 100" incentive pin to any Legion Family member who obtains three new members into The American Legion.

A new member is any eligible person joining for the 2019 membership year who was not a member of The American Legion during the 2018 . membership year.

Each member listed must be eligible for membership in The American Legion. Forward names of Sons of The American Legion members or • Auxiliary members to your detachment or unit for use in their respective • incentive programs.

Only one pin will be awarded per individual. Upon receipt, national • membership staff will confirm the names and mail the pin directly to the person who earned • • it. Commander Reistad's pin incentive program will end June 30, 2019, or when supplies are • exhausted.

National Commander's Honor Ribbon

American Legion National Commander Brett P. Reistad will award his Team 100 American Legion Family Ribbon to any American Legion Family that achieves 100 percent membership by May 30, 2019. For this award, the Legion Family is defined as a post and any combination of an Auxiliary unit, Sons squadron or Legion Riders chapter. Each branch must achieve 100 percent membership to qualify for the award.

Depression

Everyone suffers from depression from time to time. Depression is a natural defense mechanism that allows the mind to take a rest by causing an individual to withdraw from reality for a day or two. If you have been experiencing some of the following signs and symptoms *most of the day, nearly every day, for at least two weeks*, you may be suffering from depression:

- Persistent sad, anxious, or "empty" mood
- Feelings of hopelessness, or pessimism
- · Irritability
- Feelings of guilt, worthlessness, or helplessness
- Loss of interest or pleasure in hobbies and activities
- Decreased energy or fatigue
- Moving or talking more slowly
- Feeling restless or having trouble sitting still
- Difficulty concentrating, remembering, or making decisions
- Difficulty sleeping, early-morning awakening, or oversleeping
- Appetite and/or weight changes
- Thoughts of death or suicide, or suicide attempts
- Aches or pains, headaches, cramps, or digestive problems without a clear physical cause and/or that do not ease even with treatment

Prevention. Depression cannot always be avoided, but because it is often related to stress and physical problems, it is possible to lessen the chances of becoming severely depressed. Here are some tips: • take time for a favorite activity as a way to relax and relieve stress • get plenty of exercise to maintain a healthy body, to relieve tension, and to help get a good night's sleep • don't try to be Superman or Superwoman. Know your limitations and avoid stressful situations • cultivate friendships to have someone to talk to who can provide support • don't be afraid of feelings. There's nothing wrong with being mildly depressed. But if you feel it is more than mild depression, don't hesitate to see a physician.

Post Excellence Award

The American Legion's Post Excellence Awarded has added new criteria. To now qualify for the Post Excellence Award, a post is required to achieve excellence in four areas: membership, submission of the Consolidated Post Report (CPR), sharing of post history, and community activity.

The purposes of this award is membership growth, exposure of American Legion values to the youth of the community, and increased visibility of the American Legion Family through service projects. A post achieving this qualification will have had numerous post members involved in planning and achieving these goals. Many posts are most likely already active in these areas and will qualify without extra effort. Others, however, will need to increase their efforts in one or more areas to qualify for the award.

The standard to be achieved in each area is as follows:

- Membership. Post membership must be at least one member greater than the previous year. At least one post officer attends district meetings.
- Consolidated Post Report. CPRs must be submitted by July 1. The American Legion's federal charter requires the submission of an annual report to Congress on activities for the year. MyLegion.org has made it simple for a post to submit its CPR in a timely manner.
- Sharing of post history: The American Legion's Centennial web page (<u>www.legion.org/centennial</u>) allows posts to convey its legacy by sharing historical photos, videos and print material. For instructions on how to create a post profile, click here https://www.legion.org/dispatch/217282/share-your-posts-legacy.
- Community activity. The post must conduct an event that connects the local community with The American Legion post. The objective is to open your doors, welcome the community in, and educate them on what The American Legion is all about and how the post is an asset to the community. Posts do not need to have a physical building to accomplish this. This activity can be held in a park, a community center, or anywhere the post can welcome and interact with the local community.

The district commander responsible for the post will certify a post as having achieved the four specified criteria. The district commander will submit a list of posts meeting the criteria to department headquarters. That list should include the post name, phone number, address and commander's name. If possible, accompany the last two criteria with copies of press releases submitted to the local media about the projects to show that the projects were not only accomplished but that an attempt was made to enhance the image of The American Legion through local media. The copy submitted should include a date and time stamp showing receipt by the media outlet.

The department adjutant will transmit information to National Headquarters as posts qualify.

POW/MIA UPDATE OF KOREA MIA'S

As you all know, the joint statement by President Trump and Chairman Kim issued as a result of their

summit in Singapore included a commitment to repatriating and recovering remains of US service members from the North Korea. Over 55 boxes were returned that contained the remains of missing DoD personnel to the United Nations Command. Four anthropologists and one forensic photographer from DPAA conducted a preliminary review of the remains at Wonsan Airport prior to being transported to joint US air base at Osan on an USAF aircraft. The scientists performed a more detailed field forensic review. The remains were then honorably carried onto two USAF aircraft for their return to Joint Base Pearl Harbor-Hickam in Hawaii. After the dignified ceremony, the remains were accessioned into the laboratory where in-depth forensic analysis began.

Every set of remains had a paragraph of information accompanying it that included the village where the remains were found. A lot of the boxes came from the Chosin Reservoir. They had been very carefully packaged with padding and packaging that was done to a very high standard.

There was one dog tag included with the remains. The family of the service member was notified "very quickly" afterwards, he said. The DPPA has stored the DNA from family members of more than 90 percent of the missing service members, which they can use to compare with the remains. When there are compelling matches, identifications can happen quickly. But it can also take months or even a few years to narrow down the identity. Chest x-rays and dental records can also be used to identify missing service members.

North Korea also committed to allowing DPAA to begin joint recovery operations of remains in North Korea, but that has not happened yet. Here we are decades later, still searching for answers for individuals that paid the ultimate sacrifice. The fullest possible accounting of our MIAs is both a sacred obligation and a moral imperative. DPAA had a current budget of \$146 million and the House was considering adding \$20 million more for Korea recovery. It remains a high priority for the Department of Defense, not just in resources devoted to it, but also in the resolute commitment attached to it because those we send in harm's way will not be forgotten, and their families will receive resolution to their decades of uncertainty.



The American Legion Eagle Scout of the Year Program for 2019 is underway.

The program at the national level grants the winner a \$10,000 college scholarship and three other Eagle Scouts each receive a \$2,500 college scholarship. The Eagle Scout who wins the competition from Missouri will receive a \$750 college scholarship.

Prospective nominees for this award must be a registered, active member of a Boy Scout Troop, Varsity Scout Team, or Venturing Crew chartered to an American Legion Post or Auxiliary Unit or be a registered, active member of a duly chartered Boy Scout Troop, Varsity Scout Team, or Venturing Crew, and be the son or grandson of a Legionnaire or Auxiliary member; must have received the Eagle Scout award; be an active member of his religious institution and must have received the appropriate Boy Scout religious emblem; have demonstrated practical citizenship in church, school, Scouting, and community; and have reached his 15th birthday, and be enrolled in high school at the time of selection. Eagle Scouts still in high school who reached their 18th birthday during the nomination year remain eligible if otherwise qualified.

The committee needs your help in getting this information out to Scouting Units and Councils. I've sent information out to all the Districts and I need Districts to make sure their Posts have the information about the Eagle Scout of the Year program and I need Districts and Posts to advise their local Scouting units of this program. The best way to do this is through their Roundtable meetings. Contact your local Scouting Commissioner service for help in this effort. I also need your help in making sure your local Boy Scout Council gets the information about this program out to the Scouts and Units in their area.

Applications can be obtained from local posts or your District Scouting Chairman. Applications must be submitted to Department Headquarters no later than **February 15, 2019**.

VETERANS AFFAIRS & REHABILITATION UPDATE: NATIONAL, DEPARTMENT & GENERAL INTEREST

The American Legion Department of Missouri has a small but good Department Service Officer Program. We employ accredited representatives to assist veterans and their families with the VA claim and appeals process.

The purpose of having *Representation* is to have knowledgeable, lay advocates working *with* the veteran on the claim. It has been proved by General Accounting Office (GAO) that is better to work with a representative to help with your VA claim than to do your claim alone. We have a representative at each major VA facility in Missouri and at the VA Regional Benefits Office. We staff the equivalent of six "full-time" service officer positions to help veterans and claimants with claims and appeals.

We currently have a position open at Truman VA Hospital in Columbia. We prefer the applicant be a Legionnaire, although Auxiliary and SAL are also eligible to apply. The applicant must be well versed in using computers, able to type and very detail oriented, college degree is also preferred or a strong background in medical or legal fields. Please refer qualified candidates to me. I am accepting resumes via fax at 314-253-4176 or by email **LE.VBASTL@va.gov**

Our team of service officers will be at Fall Conference. We will be available Friday afternoon to discuss any issues from noon through 3:30 pm. We will be selling 50/50 raffle tickets to support our Department Operation Comfort Warriors program. This program supports rehabilitation efforts like the Soulard AMBUCS that help local veterans with different abilities gain mobility and independence through a AmTryke therapeutic cycle.

Important Reminder: VA Healthcare is not Medical Insurance... Please review what to do during a medical emergency. Emergency Medical Care

During a medical emergency, Veterans should immediately seek care at the nearest medical facility. A medical emergency is an injury, illness or symptom so severe that without immediate treatment, you believe your life or health is in danger. If you believe your life or health is in danger, call 911 or go to the nearest emergency department right away.

Veterans **do not** need to check with VA before calling for an ambulance or going to an emergency department. During a medical emergency, VA encourages all Veterans to seek immediate medical attention without delay. A claim for emergency care will never be denied based solely on VA not receiving notification prior to seeking care.

It is, however, important to promptly notify VA after receiving emergency care at a community emergency department. Notification should be made within 72 hours of admission to a community medical facility.

This allows VA to assist the Veteran in coordinating necessary care or transfer, and helps to ensure that the administrative and clinical requirements for VA to pay for the care are met. **IMPORTANT:** An emergency department (ED) is a facility that is staffed and equipped to provide emergency treatment and does not include community facilities that provide medical treatment in situations other than emergencies.

Service-Connected Emergency Care

In general, VA can pay for emergency medical care at a local ED for a Veteran's service-connected condition, or if the care is related to a Veteran's service-connected condition. Specifically, emergency medical care for a Veteran's service-connected or related (adjunct) condition(s) is eligible for VA payment as long as the VA wasn't reasonably available to provide the care.

In accordance with the following situations and requirements, VA can pay emergency care costs for:

- 1. A Veteran who receives emergency treatment of a service-connected, or adjunct condition* in a community emergency department; **OR**
- 2. A Veteran who is Permanently and Totally disabled (P&T) as the result of a service-connected condition is eligible for emergency treatment of ANY condition; **OR**
- 3. A Veteran who is participating in a VA Vocational Rehabilitation Program, and who requires emergency treatment to expedite their return to the program, is eligible for emergency treatment for any condition; **AND** (scenarios 1-3 must all meet #4)
- 4. The emergency was of such a nature that the Veteran (or other prudent layperson without medical training) would reasonably believe that any delay in seeking immediate medical attention would cause their life or health to be placed in jeopardy.

NOTE: A service-connected condition is one that has been adjudicated by the Veterans Benefits Administration (VBA) and a disability rating has been granted. An adjunct condition is one that, while not directly service-connected, is medically considered to be aggravating a service-connected condition.

Legal authorities and payment methods for VA payment for emergency care for service-connected conditions are contained in Title 38 U.S.C. §1728, 38 CFR §17.120 and 38 CFR §17.132.

Nonservice-Connected Emergency Care

VA can also pay for emergency medical care at a community ED for a Veteran's nonservice-connected condition. However, there are several requirements and factors that affect the extent to which VA can cover those services. Specifically, emergency medical care for a Veteran's nonservice-connected condition(s) is eligible for VA payment when **all** of the following five elements are true:

- 1. Care was provided in a hospital emergency department (or similar public facility held to provide emergency treatment to the public); AND
- 2. The emergency was of such a nature that the Veteran (or other prudent layperson without medical training) would reasonably believe that any delay in seeking immediate medical attention would cause their life or health to be placed in jeopardy; **AND**
- 3. A VA medical facility or another Federal facility was not reasonably available to provide the care; **AND**
- $4. \ \ The \ Veteran \ is \ enrolled \ and \ has \ received \ care \ within \ a \ VA \ facility \ during \ the \ 24 \ months \ before \ the \ emergency \ care; \ \textbf{AND}$
- 5. The Veteran is financially liable to the provider of emergency treatment.

There are limitations on VA's ability to provide coverage when a Veteran has other health insurance (OHI). If OHI does not fully cover the costs of treatment, VA can pay certain costs for which the Veteran is personally liable. By law, VA cannot pay copayments, coinsurance, deductibles, or similar payments a Veteran may owe to the provider as required by their OHI.

VA is also legally prohibited from providing coverage for individuals covered under a health plan contract because of a failure by the Veteran or the provider to comply with the provisions of that health plan contract, e.g., failure to submit a bill or medical records within specified time limits, or failure to exhaust appeals of the denial of payment.

NOTE: Legal authorities and payment methods for VA payment for emergency care for nonservice-connected conditions are contained in Title 38 U.S.C. §1725 and 38 CFR §17.1000.

Emergency Care in Foreign Counties

VA can pay for emergency medical care outside the United States if the emergency is related to a Veteran's service-connected condition. Contact the Foreign Medical Program at 1-877-345-8179 or visit our Foreign Medical Program page for more information.

Foreign Medical Program

After Receiving Care

Once a Veteran's immediate emergency medical care needs have been addressed, the Veteran, a family member, friend, or hospital staff member should contact the nearest VA medical facility within 72 hours. Once notified, VA staff will assist the Veteran and/or his/her representatives in understanding eligibility and how eligibility relates to services rendered in the community. VA staff will also ensure that, if desired, the Veteran is transferred to a VA medical center upon stabilization and that the Veteran is set up to receive additional care, post discharge, without interruption.

IMPORTANT: When a Veteran receives emergency medical care, notifying VA as quickly as possible is always best. It ensures maximum VA coverage and assists the VA in providing the Veteran with the care they need.

Filing a Claim

Claims for emergency medical care should be submitted to VA as soon as possible after care has been provided. The deadline for filing a claim depends on whether care was provided for a service-connected condition or a nonservice-connected condition. The charts below describe the requirements, how to file a claim, and payment rates.

Receiving Payment from VA

Once a claim for emergency treatment is received by VA, the claim will be administratively reviewed to determine Veteran eligibility. If the Veteran meets the administrative eligibility criteria to receive emergency care in the community, the treatment documentation will then be reviewed by VA clinical staff to determine if the treatment received meets the clinical criteria necessary for VA to pay for the care.

VA makes every effort to adjudicate claims for emergency treatment quickly and accurately. When further information or clarification is needed by VA, claims processing may be delayed.

If a Veteran is charged for emergency care received in the community and believes the charges should be covered by VA, they should contact the nearest VA medical facility as soon as possible. VA staff will assist the Veteran in understanding eligibility and in determining whether the bill received is appropriate. VA will assist the Veteran and work to resolve any billing issues with the community provider.

Emergency Transportation (Ambulance)

If you believe your life or health is in danger, call 911 or go to the nearest emergency room (ER) right away. During a medical emergency, Veterans should immediately seek medical care. A medical emergency is an injury, illness or symptom so severe that without immediate treatment, you believe your life or health is in danger.

Veterans do not need to check with VA before calling fo an ambulance or going to an ER. However, **promp** notifying the nearest VA medical facility of the emergency care and transportation is very important in VA being able to potentially reimburse costs.

When the nearest VA medical facility is notified of the emergency transportation, more information will be known of the Veterans medical condition, the availability of VA for transfer (if Veteran is stable), and other information to assist them in receiving the essary medical care.

VA Payments for Emergency Transportation

VA can pay for emergency transportation provided by unity provider for a Veteran's service-connected condition and nonservice-connected condition, but there are **specific requirements that must be met** before VA can reimburse these costs*.

- 1. Prior Authorization and/or Prompt Notification. VA must authorize transportation in advance, but in medical emergencies this may not be reasonable. As a result, promptly notifying the nearest VA medical facility of the emergency transportation can satisfy the prior authorization requirement. VA may be able to consider prompt notification of ambulance transportation, subject to the following requirements (a-c):
- a. Veteran (or someone on their behalf) notifies VA
- b. A VA or other Federal facility was not reasonably





- emergency related to a service-connected condition
- 2. Emergency Transportation for nonservice-connected condition. Along with the requirements above in 1(a) and 1(b), VA can pay for emergency transportation for a Veteran's nonservice-connected condition, subject to the additional following requirements (a-c)
- a. VA must receive and adjudicate a claim for the emergency care received as part of the emergency transportation (the administrative eligibility for payment of nonservice-connected emergency care can be reviewed <u>here</u>). If no claim is received for the associated treatment, VA cannot pay for the emergency transportation unless the following two exceptions are met
 - i. Other health insurance or a third party paid for the emergency treatment (leaving no liability for the treatment) excluding the emergency nsportation itself; or
- ii. Death occurred during transportation to receive

If VA cannot pay for emergency care outside of the above two exceptions, then it generally cannot pay for the associated emergency transportation

- b. Veteran must be liable to the provider of the
- c. If the emergency condition was caused by an ccident or work-related injury, the Veteran must first attempt to obtain reimbursement from a liable third party (i.e. employer, insurance, etc). If the Veteran's efforts to obtain reimbursement from a liable third party are denied or otherwise unsuccessful. VA may be able to pay for the




